

## **National Museums Northern Ireland Exhibition Loan Charges Schedule**

These charges will be applied to loans of NMNI accessioned objects.

Costs incurred will be recovered from the borrower as listed below:-

- Assessment of venue (travelling costs and expenses)
- Packing materials
- Framing and glazing
- Mounts
- Transport
- Insurance<sup>1</sup>
- Courier expenses<sup>2</sup>

Please be aware that charges for the following types of loans will be negotiated on a case by case basis:-

- Entire exhibitions and special events.
- Loans of large numbers of objects.
- Reciprocal or partnership loans.
- Loans for the purposes of research, conservation or restoration.
