#### General Terms and Conditions

- Digital image supply fee will be an additional £15 to the reproduction fee
- VAT will be added to all UK orders, EU customers can have VAT costs waived on receipt of VAT code.
- New and special photography can be arranged, but will incur additional fees
- Small publications (under 1000 copies) and educational publications 50% discount
- Very Small print runs (200 copies or under) – reproduction fee waived.
- 50% of initial fee for re-use rights.
- Discount for bulk supply of material (only if no other discount applies)
